

Purpose

The Pediatric Fundamental Critical Care Support (P-FCCS) program will introduce principles important in the initial care of critically ill or injured pediatric patients to physicians, nurses and other health care providers who are not skilled in pediatric critical care but who must care for such a patient in anticipation of the arrival of a pediatric intensivist or pending transfer of the patient to a more suitable facility. It provides exposure in both didactic and hands-on clinical skills (using small group format and simulation).

Objectives

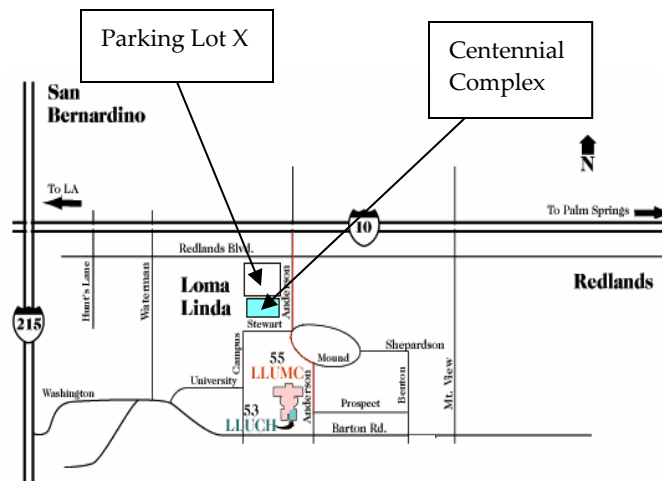
At the conclusion of this program, participants will be able to:

- Prioritize assessment needs for the critically ill or injured infant and child.
- Select appropriate diagnostic tests.
- Identify and respond to significant changes in the unstable pediatric patient.
- Recognize and initiate management of acute life-threatening conditions.
- Determine the need for expert consultation and/or patient transfer and optimally stabilize the patient for transport.
